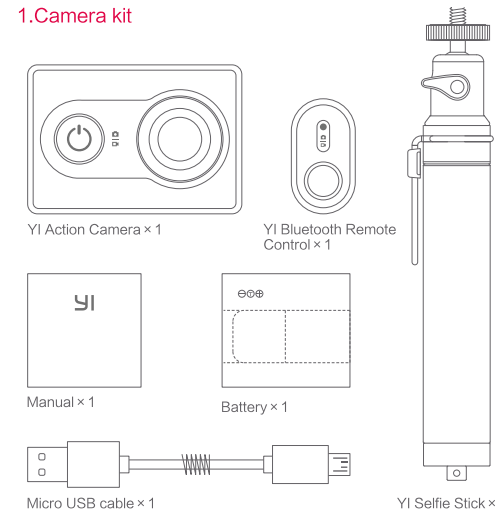


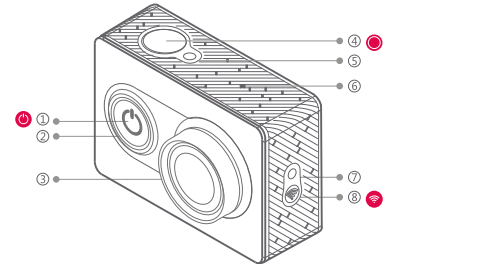


# YI Action Camera (Bluetooth Version) User Manual

## 1.Camera kit

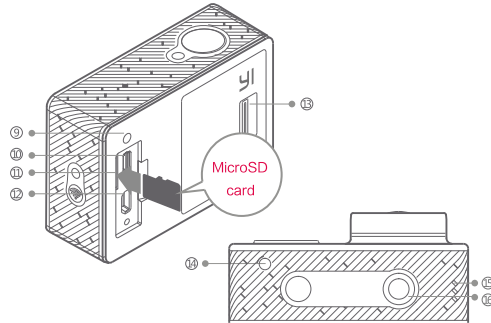


## 2.Getting to know the camera



- ① Power/Mode button
- ② Battery LED light
- ③ Lens
- ④ Shutter button
- ⑤ Status LED light
- ⑥ Microphone
- ⑦ Wi-Fi LED light
- ⑧ Wi-Fi/Bluetooth button

The camera uses Wi-Fi to connect to a phone with the YI Action app installed. Once the camera is connected to a phone, you can control your camera remotely and transfer files from your camera to your phone.

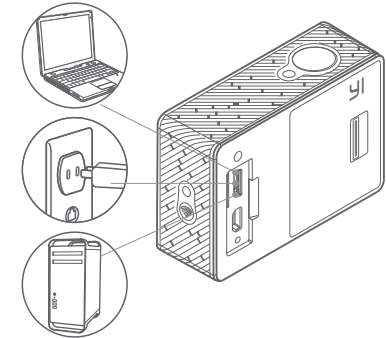


- ⑨ Status LED light

Tips: We recommend using a 16-128GB micro SD card, class 10 or UHS-1 (not included)

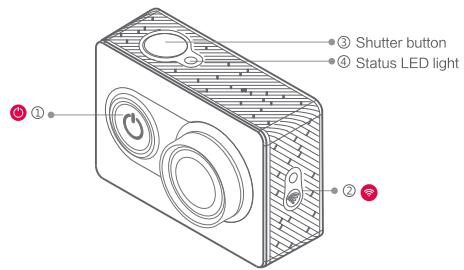
## 3.Battery charging

You can charge the camera by connecting the camera to a power adapter or a computer with a micro USB cable. When charging using a computer, the camera must be powered off.



Attention: It is illegal in many jurisdictions to record audio and/or video without the consent of all individuals. You must comply with all laws when using your YI Action Camera.

## 4.How to use the camera



- 1) Turn on the camera: Click on the Power/Mode button. The LED light will blink few times.  
Turn off the camera: Press the Power/Mode button for 3 seconds. The LED light will blink 7 times.
- 2) Turn on Wi-Fi: Click on the Wi-Fi button. The Wi-Fi LED light will start to blink.  
Turn off Wi-Fi: Click on the Wi-Fi button again. The Wi-Fi LED light will blink 5 times before turns off.

By using the app, you can control the camera or transfer files from the camera to your phone. The camera can also be controlled by a Bluetooth remote control (sold separately).

## 3) Switching camera modes

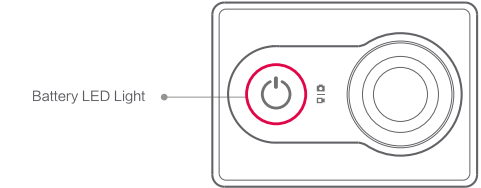
Click on the Power/Mode button quickly to switch between photo and video mode.

Photo: By default, the camera will start in photo mode (you can change the default configuration on the YI Action Camera App) Click the Shutter button to take photo.

Video: Click the Power/Mode button again to switch mode to video. Click the Shutter button to start recording. Click the Shutter button again to stop recording.

## 4) Battery LED Light

- Blue : 50%-100% charged
- Purple : 15%-49% charged
- Red : 0%-14% charged



## 5) Download the camera app

Scan the following QR code to download YI Action Camera App to preview, record/take and share videos/photos through your smart phone.



Tips: You can find the App on the App Store® or Google Play store by searching for YI Action.

## 6) Firmware update

Update through the App: Make sure the camera is connected to a power source or has more than 50% battery.

## 7) Factory settings

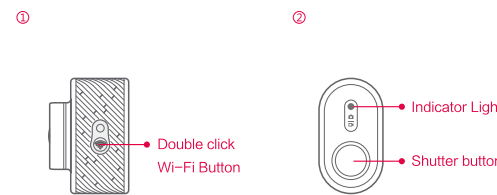
If you want to reset your settings to factory defaults, just hold down the Power and Wi-Fi buttons for two seconds. You will hear a beep when the camera is reset.

## 8) Attention

To use the camera as a car dashboard camera, remove the battery and plug the camera to a power source through the micro USB cable.

## 5.Bluetooth® Remote Control Instructions

### 1.Pairing



To turn on Bluetooth, click the Wi-Fi button on the camera twice. It will beep once the Bluetooth is on. If you have problems, wait 30 seconds after the camera is turned on and try again or update to the latest firmware on the app.

## 2. Photo / Video

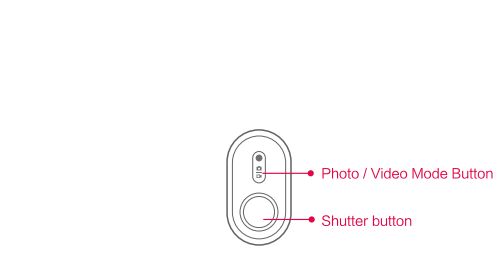


Photo Mode: Press the shutter button to take photos; Video mode: Press the shutter button to start recording a video. Press the shutter button again to stop.

Tips: Use the photo / video mode button to switch between shooting modes.

## 3.Battery Replacement

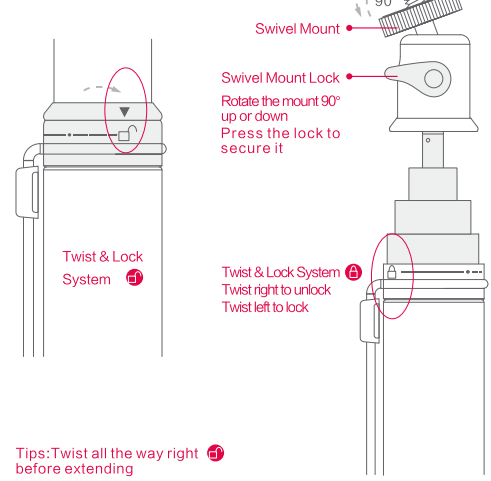


② The battery is on the back of the controller

Rotate to ① to remove the battery. Replace it with a new battery.

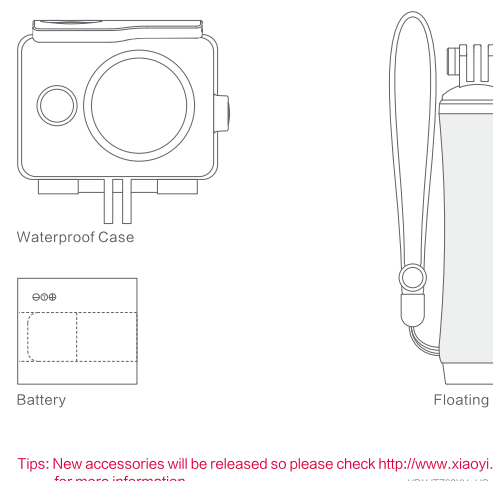
Tips: Use a coin to rotate and remove the battery
